
1 I, Tricia L. Hynes, if called upon would competently testify as follows:

2 1. I am an attorney licensed to practice before all of the courts of the State of  
3 California. I am employed by the firm of Meyers, Nave, Riback, Silver & Wilson, counsel  
4 of record for Plaintiff, the People. I have personal knowledge of the facts set forth herein  
5 and, if called upon to testify, would and could testify as set forth herein.

6 2. Some of the percipient witness declarations in support of the Plaintiff's  
7 Motion for a Preliminary Injunction contain redactions. These redactions were deemed  
8 necessary after the dismissal of some of the individual defendants. Additionally, one of  
9 the redactions was necessary to protect the identity of a crime victim. Finally, another  
10 redaction was to remove biographical information from a booking photograph. We opted  
11 to redact this information in lieu of redrafting the declarations and obtaining signatures  
12 from the individual officers because the latter course of action would have created a  
13 substantial burden.
